Digital/Media Consent form for use by school

We will not use the personal details or full names (which means first name and surname) of any child or adult in a photographic image or video, on our website, on our social media platforms in our school prospectus or in any of our other printed publications without seeking permission.

If we use photographs of individual pupils, we will not use the full name of the child in accompanying text or photo caption.
